Hi Kathy:

You are correct that the alignment of the paved shared use path is recommended for the east side of Old Bardstown Road. The graphic ALSO shows the recommended alignment of the Loop's soft surface facility on the west side of Old Bardstown Road.

Thus, I made the recommendation that Molly and/or Sam related below (**yellow highlight** by me): that the appropriate ROW dedication be made and the site be graded to accommodate the Loop facility in the future. That space can be occupied by a standard sidewalk in the meantime, if that is a development requirement.
