Good morning,

Has D05 already confirm there are no existing honorary street signs at the locations were the new honorary street signs will be place? Other than that, I have no other concerns with the CIF081324PW05 and CIF081324PW05a packets. Thank you.

Per my discussion with Mr. William Hines this morning, Public Works does not confirm if there are already honorary street signs in the locations that D5 is requesting for new honorary street signs to be placed. Public Works will only do what is requested by the district.

If a district ask for new honorary street signs to be installed, and there are already honorary street signs in those locations, Public Works will leave the initial honorary street signs up and add the new honorary street signs. Therefore, you may have two signs at the same location. However, if the district asked Public Works to remove an existing honorary street sign prior to installing a new honorary street sign, Public Works will do as requested by the district. Please be mindful others may have an issue with initial honorary street signs being removed. Thank you.
