

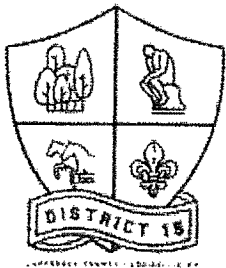

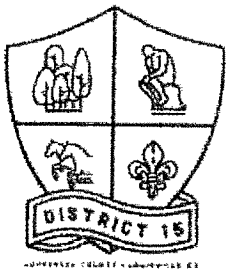

The only advantage to an official name is that EMA can start assigning addresses off it, but that can also cause a problem if someone is forced to change their address because of a new name. For what you need, the honorary is likely the best option. The official name would be better if there were new lots or housing units coming in that would need to be identified by that new street name.

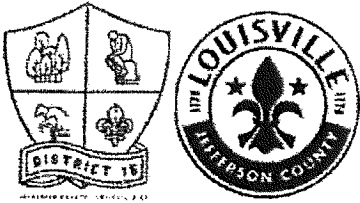

This should be a link to one of the recent alley naming ordinances, for Branden Klayko Ally. This process officially assigns a name to an unnamed alley and the application you linked below looks like the one you would use. Officially naming the street goes through the Planning Commission which makes a recommendation to Metro Council, so I think you would need to start with the Planning & Design application and the ordinance will follow the Planning Commission action.

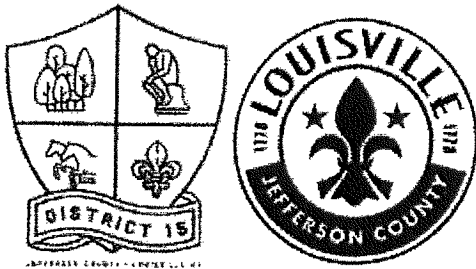
