Our office is seeking an ordinance to rescind Ordinance No. 254, Series 2024 appropriating \$6,025 from District 6 Neighborhood Development Funds to the Office of Arts and Creative Industries for a public art mural at the Three Points intersection. This ordinance is necessary due to lack of information in the Louisville Metro Council Originated NDF paperwork pertaining to the original appropriation; the ordinance did not provide enough specifics about the mural's location, despite requests to do so from Council staff and the Office of Arts and Creative Industries. This has resulted in an inability to match the planned artwork with a property owner, meaning that the project cannot be carried out, which led to a recommendation from the Office of Arts and Creative Industries to rescind the ordinance and re-submit if and when there are more detailed plans for a mural.

Unfortunately, I didn't receive much information beyond what you have outlined below. It's not clear where this request originated, how the artist was selected, or how far into project development Councilman Baker or his staff may have gotten with residents and/or the property owner. I did notice that the property owner identified in the attached email from Tony Hardin on Jan 6 (Red Top Gourmet Hot Dogs/Rail Line Food Yard) didn't directly match the property owner as listed on Lojic (D&S, Investment LLC). I believe D&S may be affiliated with the Abell Elevator Co., which is located across the street.

No one has reached out to my office to inquire about the status of the project, but I'm not sure who might still have outstanding expectations or if this was already publicly promised to neighbors. I am willing to work through this however D6 prefers, but my current thinking is that it would be cleanest for the funds to be returned to the D6 office and if CM Lyninger is interested to support a mural project in the future, we could start the process afresh with clearer scope and better documentation.
