AN ORDINANCE APPROPRIATING ~~\$1,500~~ ~~\$7,450~~ \$9,800 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: ~~\$1,500~~ \$2,000 FROM DISTRICT 9; \$1,000 FROM DISTRICT 4; \$950 FROM DISTRICT 3; \$850 FROM DISTRICT 8; \$700 FROM DISTRICT 21; \$500 EACH FROM DISTRICTS 1, 10, 17, AND 20; ~~\$450~~ EACH FROM DISTRICTS 1 AND 3; \$400 EACH FROM DISTRICTS 15 AND 21; \$350 FROM DISTRICT 24; \$300 FROM DISTRICT 13; AND \$250 EACH FROM DISTRICTS 2, 5, 12, 14, AND 16; THROUGH THE OFFICE OF BUDGET AND MANAGEMENT, TO LOUISVILLE INDEPENDENT BUSINESS ALLIANCE, INC. FOR COSTS ASSOCIATED WITH THE 2025 BUY LOCAL FAIR (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (“THE COUNCIL”) AS FOLLOWS:

**SECTION I:** The sum of ~~\$1,500~~ ~~\$7,450~~ \$9,800 is hereby appropriated from Neighborhood Development Funds in the following manner: ~~\$1,500~~ \$2,000 from District 9; \$1,000 from District 4; \$950 from District 3; \$850 from District 8; \$700 from District 21; \$500 each from Districts 1, 10, 17, and 20; ~~\$450~~ each from districts 1 and 3; \$400 each from Districts 15 and 21; \$350 from District 24; \$300 from District 13; and \$250 each from Districts 2, 5, 12, 14, and 16; through the Office of Budget and Management, to Louisville Independent Business Alliance, Inc. for costs associated with the 2025 Buy Local Fair, including advertising, design and tracking, event planning and day of contractors, volunteer t-shirts, rental equipment, supplies, and printing.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
