RE: Application for Communications Franchise Agreement

Dear Mr. Smith:

Crown Castle NG Central Inc. ("Crown Castle"), a wholly-owned indirect subsidiary of Crown Castle International Corp. ("CCIC"), is hereby making an application to the Louisville Jefferson County Metro Government ("Metro") for permission to operate within Metro rights-of-way (ROW) pursuant to the Louisville Metro Code ("Code").

The use of wireless communications networks continues to grow dramatically. In the United States wireless devices now outnumber people, over fifty percent of Americans own a smartphone, and nearly one-third of households have no wireline telephone service.¹ Wireless data traffic increased 123% from 2010 to 2011, driven by smartphones running an average of 22 "apps".² Wireless callers place nearly 400,000 9-1-1 calls each day, and soon subscribers will receive automatic emergency alerts about severe weather at their location,³ and send text messages, photos, and video to 9-1-1 centers.⁴ Wireless broadband provides Americans with increased convenience and safety, but it also created productivity gains which will add nearly \$680 billion to the United States gross domestic product (GDP) over a decade.⁵ The availability of wireless broadband connections is critical to economic growth in the United States and in the City, and Crown Castle is preparing to make a major capital investment in infrastructure to serve the City. Section 20-201 *et seq.* of the Code provides for permitting within the ROW. Crown Castle intends to comply with these permits requirements. Included with this letter please find the completed Communications Franchise Application. Also, please accept the following information to be incorporated to address the "Additional Requirements" of the application:

1. Supplementary, additional or other information:


- (a) **Description of Services to be Provided:** CCIC is the largest provider of Distributed Antenna Systems and Small Cell Networks (collectively "SCN") infrastructure in the country with over 10,000 antenna nodes on air or in construction. CCIC owns, operates and leases towers and other infrastructure, such as small cell solutions and third party land interests beneath towers for wireless communications, and is the largest wireless infrastructure operator in the United States. Founded in 1994, CCIC is a NYSE-traded company and a component company of the S&P 500 Index. Crown Castle is a "carriers' carrier" providing "RF Transport Services" that carry voice and data traffic handed off to it by wireless providers (such as cellular and PCS). It carries that traffic via its fiber optic lines to and from antennas located on utility and/or street light poles to a central network hub.
- (b) **Scope of Metro Operations:** Crown Castle has been contracted by a major wireless carrier to construct an SCN network in two areas, with the preliminary fiber network and node locations identified on the attached map. Crown Castle expects to engage in the actual construction in the right-of-way during the fourth quarter of 2014 and the first quarter of 2015. We believe the construction of these networks will bring substantial benefit to the City by providing enhanced wireless service, including fast data speeds. Once constructed, the fiber network will have the ability to support other wireless carriers and to be expanded to adjacent areas, minimizing future construction and disruption in the area. Each node location will include small telecommunications equipment deployed in the ROW as depicted in the attached node profile drawing.
2. **Copy of Applicant's Certificate of Authority:** Crown Castle has made application dated March 24, 2014 with the Kentucky Public Service Commission for a Certificate of Authority. By letter dated May 9, 2014, the PSC approved Crown Castle to provide Competitive Local Exchange Services in the Commonwealth, under Filing No. TFS2014-00205 [<http://psc.ky.gov/trf/TRFListFilings.aspx?ID=TFS2014-00205>]. A copy of the application and letter are attached. .
3. **FCC Authority:** While Crown Castle is not required to hold any federal licenses to operate the network as contemplated, Crown Castle is a federally-registered telecommunication carrier (Registration # 0010120830).
4. **Insurance:** Attached is an insurance certificate from Crown Castle naming the Louisville Jefferson County Metro Government as an additional insured. Please advise as to whether this COI is acceptable to the Louisville Metro Insurance and Risk Coordinator.
5. **Certification:** The applicant, Crown Castle NG Central LLC, agrees to be bound by all provisions of the Franchise and agrees to obtain all application permits and authorizations prior to constructing, installing or operating a System in the right-of-way

1. Applications may be modified at any time prior to the opening of the applications, provided that any modifications must be duly executed in the manner that the applicant's application must be executed.
2. Louisville Metro reserves the right to require such supplementary, additional or other information that it deems reasonable necessary for its determinations.
3. Louisville Metro reserves the right to waive all formalities and/or technicalities where the best interest of Louisville Metro may be served.
4. Franchises shall be granted in accordance with Kentucky Constitution Sections 163 and 164. All franchisees shall be required to obtain and maintain any necessary and lawful permit, license certification, grant, registration or any other authorization required by any appropriate governmental entity.
5. Any franchise granted pursuant to this application shall take effect and be in force from and after the effective date of a resolution granting a franchise, provided that on or before said date, franchisee shall:
 - a. Enter into and execute such contracts and documents as required by Louisville Metro that are consistent with the terms and provisions of LMCO § 116.71-116.99.
 - b. File certificates of insurance as required by LMCO § 116.71-116.99.
 - c. File such bond or bonds as required by LMCO § 116.71-116.99.
 - d. Advise the Director of Finance in writing of Franchisee's address for mail and official notifications from Louisville Metro.

In accordance with the provisions of Administrative Case Nos. 359 and 370, Crown Castle NG Central LLC ("Crown Castle" or "Applicant") hereby advises the Commission of its intent to provide telecommunications services throughout the State of Kentucky. Crown Castle NG Central LLC is a duly formed limited liability company, organized under the laws of the State of Delaware. Crown Castle's Certificate of Formation attached hereto as Exhibit A.

Crown Castle seeks to provide facilities-based local transport services (hereinafter referred to as "Services") to customers throughout the State of Kentucky. Crown Castle proposes to provide these Services through a combination of its own facilities and facilities to be leased from a variety of telecommunications carriers.

Applicant's Services will typically rely on a technical platform known as a "Distributed Antenna System," or "DAS." Crown Castle's "RF transport services" will use fiber optic technology, including multi-wavelength optical technology over dedicated transport facilities, to provide telecommunications companies with transport options. RF transport services connect wireless capacity equipment (i.e., antennas) to bi-directional, RF-to-optical conversion equipment at a hub facility. The hub facility can be customer or Crown Castle-provided. The conversion equipment allows Crown Castle to accept RF traffic from the customer and then send bi-directional traffic transmissions across the appropriate optical networks. At the remote end, Crown Castle or the customer company will provide RF-to-optical conversion equipment to allow bi-directional conversion between optical signals and RF signals. RF signals can be received and radiated at this remote node by the customer company.

The Services are customized to the transport and backhaul needs of individual customers. Pricing information for all non-custom services will be available on the Applicant's website.

Applicant does not intend to furnish switched residential or business telephone service, and as such, Applicant does not intend to file an interconnection agreement with the Commission. Applicant also does not seek to provide operator assisted services to traffic aggregators as defined in Administrative Case No. 330.

Repair, maintenance and all customer-affecting issues are usually directed to Crown Castle's Customer Service, which operates 24 hours a day, 7 days a week.
