Would it be possible to install a street light on the existing pole at Ashby Pointe Dr & Penile Rd?

Lisa,
If this pole can accommodate a new street light, the cost would be \$12.57/month for the Type B 250Weq LED cobra head light, so the NDF appropriation would need to be \$755 to cover the first 5 years of the minimum 5-year lease with LGE.
