

- 4 Judd Viburnum
- 1 Forest Pansy Redbud Small Tree
- 2 Honeylocust
- 1 Grouping of Nandina domestica
- 1 Grouping of Big Blue Hosta
- 1 Grouping of Variegated Hosta
- 3 Grouping of Daylilies

#### **FINISHING MATERIALS**

- 15 cu yds Compost – to improve drainage & soil
- 20 cu yds Hardwood Mulch


