AN ORDINANCE APPROPRIATING ~~\$5,000~~ \$18,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: ~~\$5,000 FROM DISTRICT 1; \$2,000 FROM DISTRICT 3; \$1,000 EACH FROM DISTRICTS 7, 8, 9, AND 24; \$750 EACH FROM DISTRICTS 5 AND 17; \$500 EACH FROM DISTRICTS 10, 12, 13, 20, 21, 22, 23, AND 26; AND \$250 EACH FROM DISTRICTS 4, 14, 15, 16, 18, AND 25;~~ THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO A-ONE ALL STARS INC. FOR COSTS ASSOCIATED WITH THE 2024 ALGONQUIN DAY FESTIVAL (AS AMENDED).


BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:


**SECTION I:** The sum of ~~\$5,000~~ \$18,000 is hereby appropriated from Neighborhood Development funds in the following manner: \$5,000 from District 1; \$2,000 from District 3; \$1,000 each from Districts 7, 8, 9, and 24; \$750 each from Districts 5 and 17; \$500 each from Districts 10, 12, 13, 20, 21, 22, 23, and 26; and \$250 each from Districts 4, 14, 15, 16, 18, and 25; through the Office of Management and Budget, to A-One All Stars Inc. for costs associated with the 2024 Algonquin Day festival.


**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.


**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.


