## OVERVIEW

Bonita's experience also includes domestic and international project financings and leasing transactions. She has also served as outside corporate counsel to several nonprofit and for profit organizations. She counsels churches on governance, financing options, and operations issues.

Prior to joining the firm, Bonita was former bond counsel to New York State Energy Research and Development Authority, New York State Housing Finance Agency, State of New York Mortgage Agency, Kentucky Housing Corporation, Brooklyn Union Gas, and Consolidated Edison Company in New York. While in house at LG&E, she also supported the company's wind farms in California, Spain, and Texas. In addition to those roles, Bonita did bond counsel work for Duke Energy and was bond counsel for Louisville Metropolitan Sewer District and Louisville Water Company, including the proposed merger of Louisville Water Company and Louisville Metropolitan Sewer District. She served as the inaugural managing partner of a regional firm's Louisville office. Bonita served as telecommunications regulatory counsel to some public utilities and has served as Special HUD counsel on single and multi-family housing transactions.
