

Based on our engineering studies, a total of three (3) speed humps and four (4) speed hump signs have been proposed for Larchmont Avenue, between Lindbergh Drive and Utah Avenue. The total "not to exceed" cost is **\$13,640.00.**

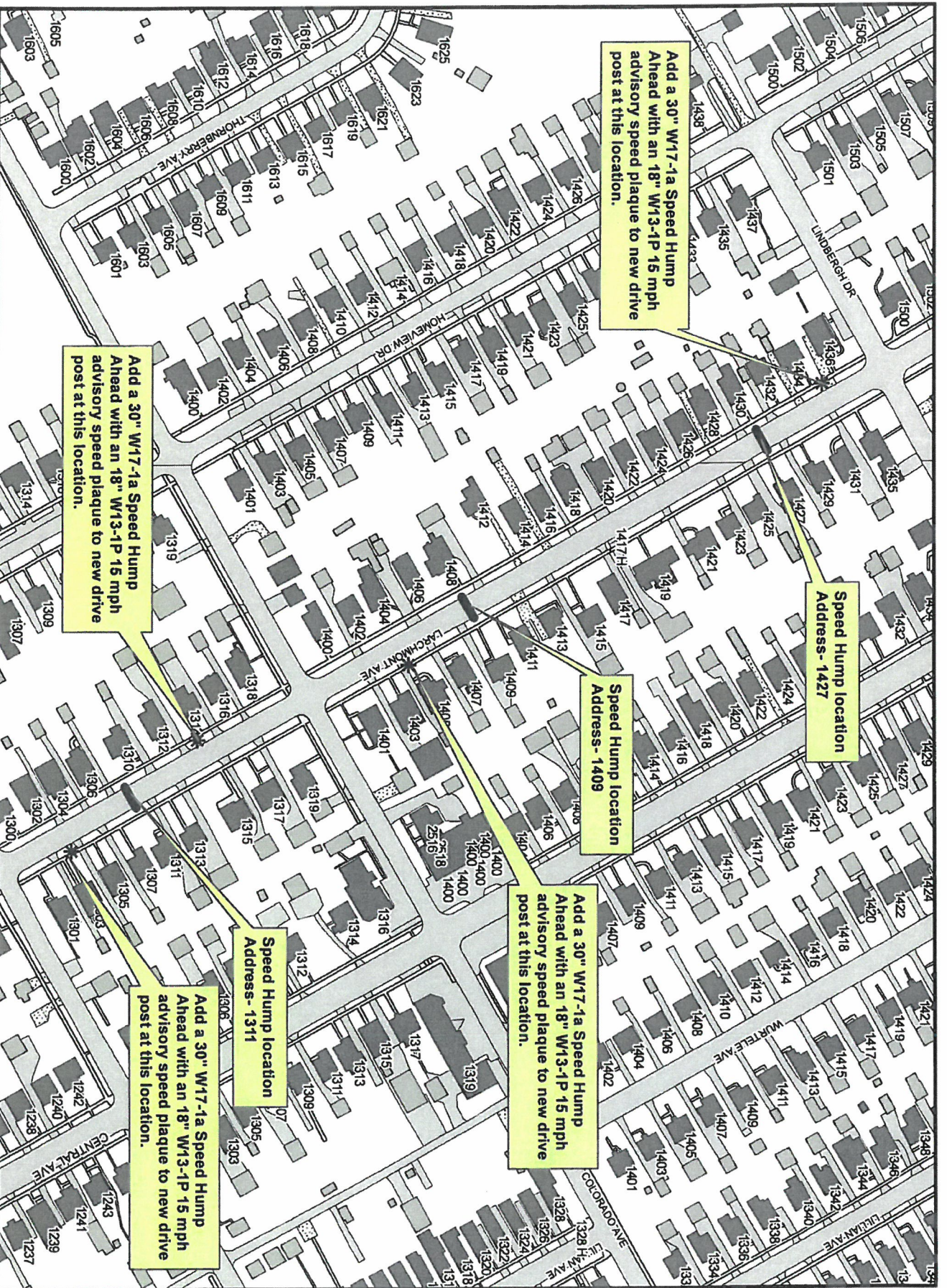
Upon funding approval, the speed humps will be installed as schedule and weather permits.

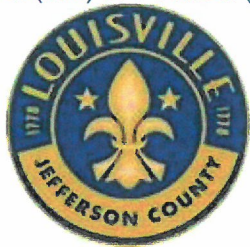

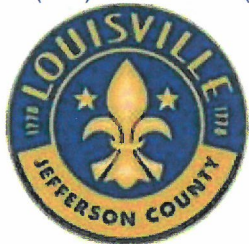
