

Purchase of software to interface with computer aided dispatch (CAD) system, integrate with Telestaff staffing software, and provide automatic vehicle location of fire department vehicles. Software will be used to dispatch closest fire units to emergency incidents, communicate with CAD via status buttons, and used by incident commanders to aid in management of emergency incidents. Software provides increased level of safety and accountability of personnel in immediately dangerous to life/ health environments. Software is compatible with existing iPad tablets that are mounted in fire department vehicles. Software will also make incident alerting available to all members on their mobile devices.


JUSTIFICATION FOR NON-COMPETITIVE GOOD/SERVICE (Attach additional documentation if necessary)

Research conducted by LFD included live demos with Tablet Command and StreetWise. Research also included examining key features of Systems Definition, Inc. accountability software and Adashi incident management software (SDI and Adashi did not have functionality to warrant a live demo). Tablet Command is the only software that provides an all in one solution for automatic vehicle location, CAD integration, scheduling integration with Telestaff, incident management capabilities, and functions on iPads currently deployed by the LFD.
