

RESOLUTION NO. 067, SERIES 2024

**A RESOLUTION REQUESTING THAT THE PLANNING COMMISSION, THROUGH THE LOUISVILLE METRO OFFICE OF PLANNING AND PURSUANT TO SECTION 6.3.3 OF THE LAND DEVELOPMENT CODE (“LDC”), INITIATE THE STREET CLOSURE PROCEDURE TO PERMANENTLY CLOSE THE PORTION OF EAST ST. CATHERINE STREET BETWEEN LOGAN STREET AND STEVE MAGRE ALLEY LOCATED IN LOUISVILLE METRO.**

**WHEREAS**, pursuant to Ordinance No. 094, Series 2019, the Legislative Council of the Louisville/Jefferson County Metro Government (“Council”) established an entertainment destination center within the Logan Street Market area, which included the sidewalks adjacent to the Logan Street Market on East St. Catherine Street; and

**WHEREAS**, a portion of the sidewalk and the northern driving lane on East St. Catherine Street between Logan Street and Steve Magre Alley is periodically being used in support of the entertainment destination center; and

**WHEREAS**, East St. Catherine Street dead-ends at the eastern side of Steve Magre Alley because there is no railroad crossing for vehicular traffic; and


**WHEREAS**, it is recommended that the portion of East St. Catherine Street between Logan Street and Steve Magre Alley be permanently closed; and


**WHEREAS**, Council wishes to direct the Planning Commission, through the Office of Planning, to initiate, pursuant to Section 6.3.3 of the Land Development Code, the procedure for permanently closing the portion of East St. Catherine Street between Logan Street and Steve Magre Alley.


**NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:**


**SECTION I:** The Council requests that the Planning Commission, through the Office of Planning and pursuant to Section 6.3.3 of the Land Development Code, initiate the formal procedure for closing the portion of East St. Catherine Street between Logan Street and Steve Magre Alley located within Louisville Metro and forward its recommendation to Council.

**SECTION II:** This Resolution shall take effect upon its passage and approval or otherwise becoming law.


