AN ORDINANCE APPROPRIATING ~~\$3,500~~ ~~\$4,500~~ \$20,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$5,000 FROM DISTRICT 13; ~~\$3,500~~ ~~\$4,500~~ FROM DISTRICT 1; \$1,750 FROM DISTRICT 3; \$1,500 EACH FROM DISTRICTS 14 AND 21; ~~AND \$1,000 EACH FROM DISTRICTS 2, 6, 12, AND 25;~~ \$500 EACH FROM DISTRICTS 5, 8, AND 17; AND \$250 FROM DISTRICT 9; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO SOUTHWEST FAMILY MINISTRIES, INC. FOR STAFFING, TRANSPORTATION, AND ELECTRICITY COSTS FOR THE EXODUS COMMUNITY RESOURCE CENTER PROVIDING SERVICES FOR UNSHELTERED INDIVIDUALS (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

SECTION I: The sum of ~~\$3,500~~ ~~\$4,500~~ \$20,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 13; ~~\$3,500~~ ~~\$4,500~~ from District 1; \$1,750 from District 3; \$1,500 each from Districts 14 and 21; ~~and \$1,000 each from Districts 2, 6, 12, and 25;~~ \$500 each from Districts 5, 8, and 17; and \$250 from District 9; through the Office of Management and Budget, to Southwest Family Ministries, Inc. for staffing, transportation, and electricity costs for the Exodus Community Resource Center providing services for unsheltered individuals.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
