AN ORDINANCE AMENDING ORDINANCE NO. 100, SERIES 2024, RELATING TO THE FISCAL YEAR 2024-2025 OPERATING BUDGET, BY TRANSFERRING \$10,000 FROM THE NEIGHBORHOOD DEVELOPMENT FUND (DISTRICT 23) TO THE LOUISVILLE METRO COUNCIL GENERAL OPERATIONS (DISTRICT 23), AND AMENDING ORDINANCE NO. 100, SERIES 2024, RELATING TO THE FISCAL YEAR 2024-2025 OPERATING BUDGET, AND ORDINANCE NO. 101, SERIES 2024, RELATING TO THE FISCAL YEAR 2024-2025 CAPITAL BUDGET BY TRANSFERRING \$20,000 FROM THE NEIGHBORHOOD DEVELOPMENT FUND (DISTRICT 19) TO THE CAPITAL INFRASTRUCTURE FUND (DISTRICT 19) (AS AMENDED).
