A) Periodically review the implementation of displacement assessment program and provide recommendations as to any needed amendments to LMCO 169.05 to Mayor and Council; B) Review results of investigations by Human Relations Commission or any Metro Agency into discriminatory practices by Metro Govt or third parties against households/businesses within Metro, subject o KRS 344, and recommend to Mayor and Council needed amendments to LMCO 169.05; C) Partner with Louisville Affordable Housing Trust Fund and Office on updating the Housing Needs Assessment every 5 years; D) Review final orders/decisions of the by Human Relations Commission that Metro discriminated against households/businesses within Metro and to refer households/businesses to Metro Government programs: (1) Down payment assistance; (2) Home repair funds; (3) Property reunification; (4) Any other programs that provide assistance against gentrification.

Appointment by the Mayor and approved by Metro Council 3 years Initial terms staggered 3 one year terms, 3 two year terms, 3 three year terms

Qualification of Members

Appointments should reflect the average percent of renters and homeowners in Displacement Risk area. 9 voting members must have lived in any Displacement Area for at least 7 collective years prior to the date of appointment and must maintain primary residence in their neighborhood during the term of appointment. May not be a real estate developer and must disclose, in writing, any personal/family commercial interest in land use, new development supply, or new development construction.

Members may not be employed as a real estate developer. All members shall be required to disclose, in writing, any personal or family commercial interest relevant to land use, new development supply or new development construction.

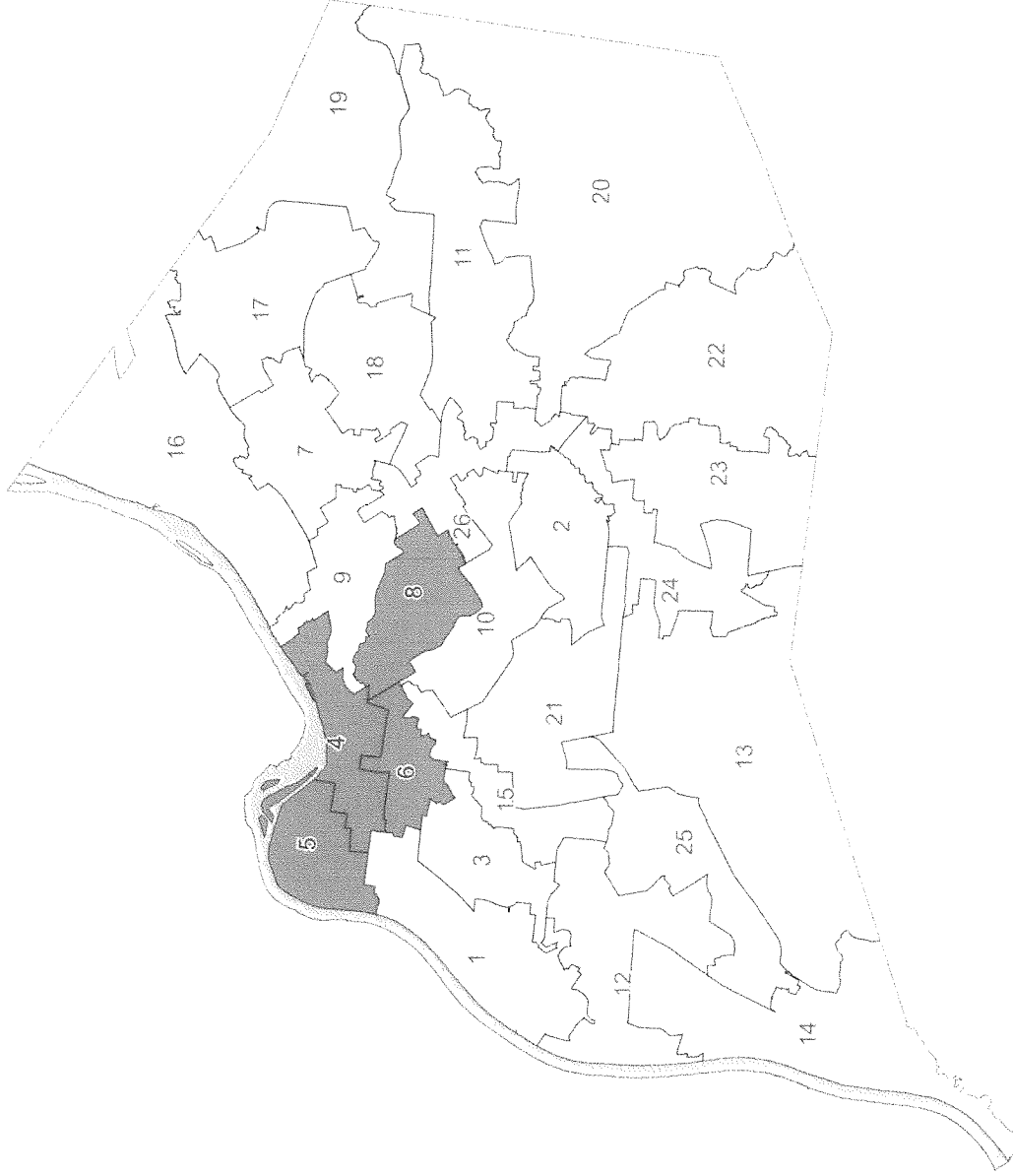
