**AN ORDINANCE AMENDING ORDINANCE NO. 080, SERIES 2023, RELATING TO THE FISCAL YEAR 2023-2024 CAPITAL BUDGET AND ORDINANCE NO. 100, SERIES 2024, RELATING TO THE FISCAL YEAR 2024-2025 OPERATING BUDGET, BY TRANSFERRING \$213,776.50 FROM THE CAPITAL PROJECT TITLED LOUISVILLE MUHAMMAD ALI CENTER IMPROVEMENTS TO THE OPERATING BUDGET FOR OPERATIONAL PURPOSES.**
