I spoke to Regina about this project, and I wanted to clarify a few things. First, Jim Mims reached out to me directly about completing this “wheelchair accessibility” work at the crossing and I gave the ok to move forward and told him D9 would pay for it. We moved forward with the work quickly because CSX had just completed their improvement of the railroad crossing at Reservoir. They already had the required permit in place that shut the road down to traffic and in order to take advantage of the open permit we fast tracked the process. Good morning again,

Regina, per our phone discussion today, you stated Public Works took it upon themselves to perform the formed and poured concrete ramp project located at Reservoir Avenue and Frankfort Avenue over the CSX train tracks **without consulting with District 9 first**. You stated Public Works completed the project, then the department informed District 9 of the project and asked District 9 to fund the completed project. Based on the information in the CIF073024PW09 packet and the information you shared with me, **CIF073024PW09 does not comply with the Metro Council Policies and Procedures, because the district should have submitted the CIF appropriation request to the LED and Appropriations Committee for consideration before commitment of the funds and before the event/project took place, similar to sidewalk repair and paving projects.**

Technically, Public Works should fund the project since it conducted the project without obtaining District 9's commitment to fund the project and the Committee approval prior to the department conducting the project. Also, I asked if you had any written documentation from Public Works indicating the property location where the work was conducted is in a public right of way or is own by Metro Government.

Please be mindful that based on the above information, the Committee may not approve CIF073024PW09 unless District 9 can provide a justification of why the CIF should be funded, or the district may want to withdraw the CIF request.
