First, I should say, we are not opposed to the new "pet resort". It seems like a good use for this land along this protected scenic road. And as it is a conditional use permit, we feel it is in keeping with the old Henry road SUBAREA plan.

However, we do still strongly object to any road signage. The intended use for this property is strictly residential and any commercial signage should not be allowed.

The developers plan shows more than adequate signage on the face of the building. As this is a destination business and not a business that needs roadway advertising, the 12 square foot monument sign should not be needed. A simple address marking should be all that is allowed.

Please review this with the developer and owner for further consideration. And please remember that standard signage rules in chapter 8 only apply in unprotected zoning areas.
