There's already a road (Distler) not 30 yards away. This "entry/exit" will be almost directly across from one of my properties at 1921 Lower Hunters. This property is connected to my primary residence that faces Oak Lea Dr..

I also have major concerns once these properties are built, as the "comps" real estate folks use to determine value will create negative impacts for those around here.

I'm unfamiliar with your processes, but would appreciate any considerations that would dramatically scale back this project.
