AN ORDINANCE APPROPRIATING ~~\$1,000~~ ~~\$2,500~~ \$7,500 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,000 EACH FROM DISTRICTS 3 AND 9; ~~AND \$500 EACH FROM DISTRICTS 1, 7, 10, 12, 13, 14, 20, 22, 23, AND 24; AND \$250 EACH FROM DISTRICTS 15 AND 18;~~ THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO ST. JOSEPH CATHOLIC ORPHAN SOCIETY FOR COSTS ASSOCIATED WITH THE ST. JOE'S 175<sup>TH</sup> ANNUAL PICNIC (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

**SECTION I:** The sum of ~~\$1,000~~ ~~\$2,500~~ \$7,500 is hereby appropriated from Neighborhood Development funds in the following manner: \$1,000 each from Districts 3 and 9; ~~and \$500 each from Districts 1, 7, 10, 12, 13, 14, 20, 22, 23, and 24; and \$250 each from Districts 15 and 18;~~ through the Office of Management and Budget, to Saint Joseph Catholic Orphan Society for costs associated with St. Joe's 175<sup>th</sup> Annual Picnic, including sanitation costs, security, fencing, stage production, parking, insurance, golf cart rentals, and other community safety costs.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
