>> PRESIDENT JAMES: THE LOUISVILLE METRO COUNCIL COMMITTEE OF THE WHOLE WILL NOW RECONVENE FROM CLOSED SESSION. A MOTION AND A SECOND.

>> PRESIDENT JAMES: A MOTION BY COUNCIL MEMBER BENSON. ALL IN FAVOR, SAY, "AYE." OPPOSED. THE AYES HAVE IT. WE'RE BACK IN OPEN SESSION. PURSUANT TO KRS61.815, SUBSECTION C, NO ACTIONS WERE TAKEN DURING THE CLOSED SESSION. THERE IS NOTHING TO DISCUSS. WE'LL STAND ADJOURNED. THANK YOU. [ GAVEL ] LOUISVILLE METRO COUNCIL REGULAR MEETING WILL BEGIN SHORTLY [PLEASE STAND BY] [ GAVEL ]

>> PRESIDENT JAMES: THE LOUISVILLE METRO COUNCIL MEETING OF JULY THE 23RD, 2020 WILL PLEASE COME TO ORDER. I'M LOUISVILLE METRO COUNCIL PRESIDENT, PRESIDENT JAMES. PLEASE RISE FOR THE PLEDGE OF ALLEGIANCE. [PLEDGE OF ALLEGIANCE]

>> PRESIDENT JAMES: COLLEAGUES, I WOULD LIKE TO REMIND EVERYONE TO MAKE SURE YOU ARE ON MUTE BEFORE WE BEGIN. COLLEAGUES, WE HAVE SEEN AN INCREASE IN COVID-19 CASES IN LOUISVILLE AND ACROSS OUR STATE. AS OF YESTERDAY, 232 LOUISVILLIANS HAVE DIED DUE TO COVID-19. AS OF YESTERDAY, 5,456 LOUISVILLIANS TESTED POSITIVE. WE KNOW MORE OF OUR FAMILIES, FRIENDS AND NEIGHBORS WOULD BE AFFECTED BY COVID-19. AND WE KNOW WE WILL LOSE MORE PEOPLE. AND WE FACE THIS CRISIS TOGETHER. AS YOU ALL KNOW, WE LOST A CLOSE FRIEND TO MANY OF US, TYLER GIRTH, ONLY 27 YEARS OLD WHEN HE WAS FATALLY SHOT IN JACKSON SQUARE.

HIS LIFE WAS CUT SHORT. AND HIS MANTRA WAS BE EXCELLENT TO EACH OTHER. HE EMBODIED HIS AS HE STOOD AGAINST RACIAL INEQUALITY AND SERVED AS WITNESS TO THE PROTEST IN THE JEFFERSON SQUARE. I HAD THE HONOR TO SPEAK TO HIS FATHER TODAY. AND IT WAS A PAINFUL CONVERSATION. WE LOST A GIANT AMONG US THIS WEEK, JOHN LEWIS, A LEGENDARY CIVIL RIGHTS ACTIVISTS, MARCHED WITH MARTIN LUTHER KING JR. AND BECAME ONE OF THE MOST CELEBRATED IN WASHINGTON D.C. AS A FIGHTER FOR JUSTICE. WE'RE ONE PEOPLE WITH ONE FAMILY, WE ALL LIVE IN THE SAME HOUSE. THROUGH BOOKS AND INFORMATION, WE MUST FIND A WAY TO SAY TO PEOPLE WE MUST LAY DOWN THE BURDEN OF HATE FOR HATE IS TOO HEAVY A BURDEN TO BEAR, AS JOHN LEWIS SAID. PLEASE JOIN ME, EVERYBODY, IN A MOMENT OF SILENCE. [MOMENT OF SILENCE OBSERVED]

>> PRESIDENT JAMES: THANK YOU. THIS MEETING IS BE CONDUCTED BY VIDEO TELL CONFERENCE PERSAUNT TO K ARE S61.826 AND SENATE BILL 150, MEMBERS ARE PRESENT IN CHAMBERS. COUNCIL MEMBER GEORGE, ACKERSON, WINGLER, PIAGENTINI, READ, AND ENGEL AND MYSELF. AND OTHERS AND PARTICIPATING VIRTUALLY. THE MEETING WILL BE SUSPENDED FOR FIVE MINUTES IF WE HAVE A DISRUPTION OF THE VIDEO FEED WHILE WE MAKE A REASONABLE ATTEMPT TO FIX THE ISSUE. WHILE IT'S SUSPENDED ALL DISCUSSION OF PUBLIC BUSINESS WILL CEASE, NO ACTION TAKEN. IF AFTER FIVE MINUTES THE ISSUE CONTINUES, WE WILL RESUME THE MEETING. AND THE MEETING WILL CONTINUE AS LONG AS WE HAVE A QUORUM OF MEMBERS. IF WE

>> I'LL START THE INTRODUCTION AS SOPHIA BAETE IS A  
DISTRICT 23 RESIDENT. SHE'S A LIFE LONG FRIEND TO COUNCILMAN  
REED, I'LL LET HIM TALK ABOUT THE EMBARRASSING THINGS. SOPHIA  
WHO STARTED, DISCOVERED, I'LL USE THOSE TERMS IN MIDDLE SCHOOL  
HAS RECENTLY GRADUATED WITH A FULL RIDE TO THE JUILLIARD SCHOOL  
OF PERFORMING ARTS. [ APPLAUSE ]

>> WE KIND OF TALKED THROUGH THIS AT THE BEGINNING OF THE  
SUMMER. AND [ OFF MIC ] BACK IN CHAMBERS. WHERE AGAIN, I SAID  
THIS EARLIER TO THE COMMITTEE OF THE WHOLE, IF WE WOULD HAVE  
GIVEN HER A MIC, I HOPE AS SHE COMES BACK AND WE GET AN AIR OF  
NORMALCY BACK TO OUR LIVES AND THE CONCERT SERIES OR SOME OTHER  
EVENT, WE CAN GET HER TO PERFORM. IT'S NOT TOO MANY FUTURE OPERA

STARS WE GET COMING OUT OF LOUISVILLE. I'M GOING TO TURN IT OVER TO SCOTT. I WILL SAY I PRESENTED HER WITH HER CERTIFICATE, WHICH SHE MAY OR MAY NOT BE HOLDING UP. SHE'S NOT ON MY SCREEN AT THE MOMENT. I PRESENTED IT TODAY ON HER FRONT PORCH. MOM AND SOPHIA WERE QUITE PLEASED. I'LL TURN IT OVER TO SCOTT. THANK YOU.

>> THAT YOU MEAN, COUNCIL MEMBER PEDEN. NOTES ABOUT JUILLIARD. ONLY 6% OF 2500 APPLICANTS ADMITTED. OF THE APPROXIMATE 650 STUDENTS, 600 ARE MUSIC MAJORS. JUILLIARD IS TO VOCAL MUSIC AS HARVARD IS TO LAW AS MIT IS TO ENGINEERING. SO TO BE ADMITTED INTO JUILLIARD IS QUITE AN HONOR AND ACCOMPLISHMENT. I WILL SAY THAT HAVING SANG MYSELF IN HIGH SCHOOL, NOT ANYWHERE NEAR LIKE THIS, IT TAKES AN ENORMOUS AMOUNT OF EFFORT AND PERSEVERANCE AND DEDICATION. IT'S ONE THING TO BE BORN WITH THE TALENT. IT'S ANOTHER TO TAKE THAT TALENT AND WORK AT IT AND HONE IT AND MOLD IT. I'VE HEARD SOPHIA SING. SHE HAS THE "X" FACTOR. NOT ONLY BLESSED WITH GREAT MUSICAL GENES BUT A GREAT STAGE PRESENCE. I KNOW SHE'S GOING TO BE VERY SUCCESSFUL. SHE HAS A WONDERFUL FAMILY. A FOLK IMMEDIATE FAMILY. ALSO IT'S A SPECIAL SHOUT-OUT TO ROBERTA BERRY, THEY HAD TO DRIVE HER TO PRACTICE. AND I CAN CONGRATULATE YOU AND MAKE YOUR FAMILY PROUD AND ALL OF US PROUD. THANK YOU.

>> PRESIDENT JAMES: THANK YOU. CONGRATULATIONS. SOPHIA, DO YOU HAVE ANYTHING YOU WOULD LIKE TO SAY?

>> I JUST WANT TO THANK YOU ALL SO MUCH FOR THIS HONOR. IT HAS BEEN JUST A WORLD WIND LATELY. BUT IT'S SO AMAZING TO HAVE THIS HONOR. AND I JUST AM SO THANKFUL. THANK YOU SO MUCH.

>> PRESIDENT JAMES: THANK YOU. ANYBODY HAVE ANYONE ELSE THEY WOULD LIKE TO SAY TO SOPHIA?

>> YES.

>> PRESIDENT JAMES: COUNCIL MEMBER SEXTON SMITH.

>> COUNCIL MEMBER SEXTON SMITH: I JUST WANTED TO ADD -- ASK SOPHIA WHERE SHE WENT TO HIGH SCHOOL AND IF SHE'S DONE WITH THE LOUISVILLE YOUTH CHOIR AND PERFORMED FOR THE KENTUCKY OPERA.

>> OKAY. SO I GRADUATED FROM THE PERFORMING ARTS SCHOOL DIRECTLY IN RELATION WITH DOWNTOWN. AND I DID DO THE LOUISVILLE YOUTH CHOIR FOR ONE YEAR. IT WAS SO ENJOYABLE, A GREAT EXPERIENCE. AND I ACTUALLY HAVEN'T DONE ANYTHING WITH THE KENTUCKY OPERA. I HAVE AUDITIONED BEFORE BUT I'M 17 YEARS OLD. THEY ARE NOT LOOKING FOR A 17-YEAR-OLD.

>> PRESIDENT JAMES: ALL RIGHT. THANK YOU VERY MUCH. BRAVO. CONGRATULATIONS. [ APPLAUSE ]

>> PRESIDENT JAMES: VERY PROUD OF YOU. MADAM CLERK, ARE THERE ANY ADDRESSES TO COUNCIL?

>> MADAM CLERK: YES, SIR.

>> PRESIDENT JAMES: LET ME REMIND THOSE, REFRAIN FROM USING PROFANITY OR MAKING DEROGATORY STATEMENT TODAY COUNCILMEMBERS. CLERK, BRING THEM FORWARD.

>> MADAM CLERK: LAMONT COLLINS.

>> YES? HELLO? CAN YOU SEE ME?

>> PRESIDENT JAMES: YES, SIR, WE CAN SEE YOU.

>> ALL RIGHT. COOL. OKAY. I'M LAMONT COLLINS. AFRICAN AMERICAN MUSEUM LOCATED 819 WEST MAIN STREET. THANK YOU FOR ALLOWING ME TO TALK ABOUT ROOT 101. WE'VE GOT NATIONAL ATTENTION. FEATURED IN SALON.COM AND WALL STREET JOURNAL AND RECENTLY VOTED TOP 20 IN THE WORLD COMING IN 2020 BY ARCHITECT DIGEST. I CAME BECAUSE WE'RE LOOKING FOR SUPPORT WHAT HAPPENED DURING THE CORPORATE CRISIS. WE WERE NOT ABLE TO CONTINUE OUR EXPANSION OF THE MUSEUM. THE MUSEUM IS AN AFRICAN AMERICAN MUSEUM, ONLY ONE OF ITS TYPE IN LOUISVILLE, KENTUCKY, TELLING THE STORY OF THE AFRICAN AMERICAN JOURNEY, THE STORY THAT NEEDS TO BE TOLD. HELLO?

>> MADAM CLERK: THANK YOU, SIR. [BEEPING]

>> MADAM CLERK: EMORY WILLIAMSON.

>> I'M SORRY. CAN'T HEAR YOU.

>> WE'RE LOOKING FOR THE SUPPORT FOR THE MUSEUM. WE'RE GETTING NATIONAL ATTENTION. WE'VE SIGNED A CONTRACT WITH THE LOUISVILLE TOURISM TO BE A FEATURED EXHIBIT, ON MUSEUM ROAD. AND WE'RE LOOKING FOR SUPPORT TO CONTINUE WHAT WE'RE DOING. THANK YOU. [BEEPING]

>> MADAM CLERK: EMORY WILLIAMSON.

>> HI, MY NAME IS EMORY WILLIAMSON. A RESIDENT OF DISTRICT 4. LAST YEAR WHEN THE GLOBAL PANDEMIC SEEMED AS DISTANCE AS NORMALCY TODAY, I WALKED THE STREETS DOWN FOR THE FESTIVAL. AS A RESIDENT OF DOWNTOWN LOUISVILLE IN DISTRICT 4 I HAVE GIVEN MANY TOURS OF THE HEART OF OUR CITY AND NEIGHBORHOOD I LOVE. THE TONE WAS VIBRANCY AND EXCITEMENT. I SHOWED THE MUSEUMS, OUR DEVELOPMENT PROJECTS AND HIGHLIGHTED OUR COMMITMENT TO LOCAL BUSINESSES. I EVEN PROUDLY CLAIMED THAT LOUISVILLE WAS A COMPASSIONATE CITY AND WELCOME DIVERSITY, PROMOTE INCLUSION AND ENSURE EQUITY. AS WE WALKED BY THE EMW WOMEN'S SURGICAL CENTER AT THE CORNER OF SECOND AND MARKET, THE TONE SHIFTS. THE WORD DISGUSTING, DEPLORABLE AND HORRIFYING ARE SAID TO ME. WE WATCHED IN HORROR AS FOLKS WERE INUNDATED WITH HARASSMENT. WHAT A NIGHTMARE. SHE ASKED ME, HOW CAN YOUR CITY CALL ITSELF COMPASSIONATE WHEN IT CAN'T PROVIDE SAFETY FOR THOSE AT THE CLINIC. I DIDN'T HAVE AN ANSWER TODAY AND I DON'T TODAY. THEY COULDN'T UNDERSTAND HOW THAT WAS NO PROTECTION FOR THE PATIENT WHO CHOOSE TO USE THE SERVICES OF THE CENTER. I SUPPORT PROTESTERS BUT THIS IS CRAZY AND UNSAFE. THE TOUR THAT DAY MANY OTHER OCCASIONS, CENTERED ON THE CITY'S POINT OF PRIDE DERAILED AND ALWAYS IS BY THE LACK OF SAFETY AT THE CLINIC. THAT'S WHERE YOU, OUR METRO COUNCILMEMBERS, CAN BE PROACTIVE AND MAKE A POSITIVE CHANGE, FOR THE CENTER AND HEALTHCARE FACILITIES NEED A SAFETY ZONE. IMPLEMENTATION OF A SAFETY ZONE IS IMPERATIVE TO

ENSURE THE SAFETY OF THE PATIENTS, HEALTHCARE PROVIDERS AND VISITORS TO OUR CITY. AFFECT IN PITTSBURGH, PENSACOLA AND LOUISVILLE ON A TEMPORARY SAFETY ZONE WAS IN PLACE IN 2017. WE NEED ONE. PRIVATE SECURITY AND SURVEILLANCE CAMERAS CAN DOCUMENT VIOLATIONS OF SAFETY MEASURES. IT WILL BE UP TO THE COURTS TO ENFORCE THE LAW. YOU HAVE TO POWER TO CREATE THE ZONE TO KEEP OUR CITIZENS SAFER. YOUR ACTION CAN PROTECT PATIENTS, ENSURE VISITORS FEEL SAFE AND BOOST OUR ECONOMY AND MAINTAIN OUR COMMITMENT AND PROMISE AS A PASSIONATE CITY. I IMPLORE YOU TO TAKE ACTION AND SHIFT THE TONE ONCE AGAIN. THANK YOU. [BEEPING]

>> MADAM CLERK: LENORA MOORE. CORRIE ARMSTRONG.

>> HELLO? CAN YOU HEAR ME?

>> MADAM CLERK: YES.

>> GOOD. HELLO. MY NAME IS CORINE, I'M HERE TO BAN 5G FOR THE SAFETY OF OUR CITIZENS AND ENVIRONMENT. MANY PEOPLE ARE FAMILIAR WITH THE INTERNATIONAL APPEAL TO STOP 5G AND PROVIDED A LINK. ONLINE YOU WILL FIND LINKS TO THE SOURCES SITED. AS OF TODAY, THERE ARE 282,313 SIGNATORIES FROM 218 NATIONS AND TERRITORIES SENT TO THE U.N., EU, COUNCIL OF EUROPE AND GOVERNMENT OF ALL NATIONS. THIS IS A COMPILATION OF RESEARCH ALONG WITH STUDIED BACKED BY SCIENTIST, ENVIRONMENTAL ORGANIZATIONS AND CITIZENS CALLING FOR THE HALT OF 5G NETWORKS AND SATELLITES. DEPLOYMENTS CONSTITUTES AN EXPERIMENT OF HUMANITY AND ENVIRONMENT A CRIME UNDER INTERNATIONAL LAW.

DESPITE DENIAL FROM THE FCC AND MASS MEDIA, THE EVIDENCE OF RADIO FREQUENCY RADIATION, RF RADIATION IS HARMFUL TO THE LIFE OF OUR MASSIVELY OVERWHELMING. MISS CARRIAGE, NEUROLOGICAL DAMAGE, OBESITY AND DIABETES, AND LAST BUT NOT LEAST, OXIDATIVE STRESS WHEN MEANS HARD FOR YOU TO BREATHE. WHY WOULD THE FCC DELIBERATELY IGNORE THESE? THERE ARE MAJOR CONFLICTS OF INTEREST OF THE FCC DUE TO RELATIONSHIP WITH TELECOMMUNICATION COMPANIES, ESPECIALLY VERIZON. IN LOUISVILLE WE HAVE 5G HARDWARE BUT ONLY RESIDENTIAL AREA THAT IS 5G ACTIVE IS IN FRONT OF PARK HILL APARTMENTS, WHICH IS HOME TO MOSTLY LOW-INCOME BLACK PEOPLE. IF THE CITIZENS EXPERIENCE THE SYMPTOMS, IT'S LIKELY IT WOULD BE MARKED WITH COVID-19 LIKE EVERYTHING ELSE, WHICH COULD LEAD TO A QUARANTINE FOR NO REASON. WHY THIS AREA? I ASKED YOU HOW MUCH ARE WE SUPPOSE TO TAKE AS A SPECIES. OUR WATER IS POISONED WITH FLUORIDE, CHEM TRAILS. HARMFUL VACCINATION AND TRYING TO DESTROY THE PLANET. PLEASE -- [ OFF MIC ] NOT ONLY FOR OUR NOISE NOISE -

- [BACKGROUND NOISE] SIGN IT AND SHARE IT AND KEEP LOUISVILLE SAFE. THANK YOU.
