#### Agency Testimony:

00:50:20 Joe Haberman provided an overview of the amendments to the zoning ordinances related to Gaming Facility Uses and charitable gaming in a specific area. Haberman provided recommendations allowing gaming facilities in specified zones (C2, C3, CM, and EZ1), with an additional proposal to allow smaller facilities in C1 zones. Haberman emphasizes that existing lawful gaming facilities would not become non-conforming under the new regulations. Haberman responded to questions from the commissioners. 01:00:00 Joe Haberman mentioned that while there are no objections to charitable gaming, Churchill Downs has concerns about how the proposed regulations might impact their operations in C3 and possibly C2 zones. (See recording for details).

#### Summary of testimony of those in favor:

01:04:50 Mike Mulrooney, Founder of Shirley's Way emphasized the significant impact of charitable gaming on their organization and community initiatives. Mike Mulberry emphasized that charitable gaming provides crucial funds without the traditional challenges of fundraising, such as reliance on donations and volunteer efforts. Mulrooney highlighted how charitable gaming supports local entertainment and community services, including feeding children, supporting local schools, funding organizations like the PRP

01:11:40 Council woman Cindi Fowler mentioned recent state law changes necessitating a clear definition of charitable gaming. Fowler stated that Churchill Downs' concerns seem related to non-charitable gaming aspects, not the charitable gaming component of the proposal. (See recording for details).

Haberman stated that despite any decision made today, there will still be further discussions with Churchill Downs to gather more detailed feedback.
