**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:**

**SECTION I:** The sum of \$15,250 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 13; \$3,000 from District 14; \$2,000 from District 12; \$1,500 from District 23; \$1,000 from District 25; \$500 each from Districts 10, 15, 21, 22, and 24; and \$250 from District 9; to Metro Parks for costs associated with the 2023 Annual Forest Fest Bluegrass Festival.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
