AN ORDINANCE APPROPRIATING ~~\$2,050~~ ~~\$3,300~~ \$7,800 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,200 FROM DISTRICT 19; \$750 EACH FROM DISTRICTS 17 AND 21; \$500 EACH FROM DISTRICTS 7, 8, 13, 16, 22, AND 23; ~~AND \$300 EACH FROM DISTRICTS 3 AND 14;~~ ~~AND \$250 EACH FROM DISTRICTS 1, 2, 5, 9, 10, AND 18;~~ THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO VETERANS CLUB INC. FOR COSTS ASSOCIATED WITH THE H.E.R.O. 5K FUNDRAISER RAISING FUNDS FOR LOCAL SUPPORT OF VETERANS (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of ~~\$2,050~~ ~~\$3,300~~ \$7,800 is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,200 from District 19; \$750 each from Districts 17 AND 21; \$500 each from Districts 7, 8, 13, 16, 22, and 23; ~~and~~ \$300 each from Districts 3 and 14; and \$250 each from Districts 1, 2, 5, 9, 10, and 18; through the Office of Management and Budget, to Veterans Club, Inc., for costs associated with the H.E.R.O. 5K fundraiser raising funds for local support of veterans.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
