00:29:37 Steve Porter thanked Ms. Casey, the consultants and the neighbors. The plan addresses the issues of home ownership and retaining trees which is very important to the neighborhood (see recording for detailed presentation).

00:31:54 Marilyn Williams said the underdeveloped area is 13.2%, which still may not be completely correct for the year 2023. The vacant properties are owned but need renovations. Also, the tree canopy is at 42% but there's concern that if there is future

00:38:11 Barba Benjamin Coffield said the 39% tree canopy could be significantly lower (see recording for detailed presentation).

Summary of testimony of those in opposition:

00:40:26 Cliff Ashburner listed the following critiques of the plan: a plan is in the works and will be under the guidelines of the Comprehensive Plan 2040 only; distinction between home ownership and rental; recommends changing “seek developers and developments that increase affordable ownership for residents” to “increase affordable housing options”; home ownership rate; and the inclusion of the properties on the east side of N. English Station Rd. (see recording for detailed presentation).

Cliff Ashburner said he is in favor of the following: parks; community identity; and emphasis on creating a safe pedestrian environment.

Cliff Ashburner said the boundaries should be reduced (see recording for detailed presentation).

00:52:40 Acting Chair Howard said the east side of English Station Rd. has always been a part of the Berrytown boundary (see recording for detailed presentation).

Rebuttal

00:55:00 Rachel Casey said this neighborhood plan will most likely not affect the properties on the east side of English Station Rd. The industrial uses will be allowed by right. Also, there’s nothing in the recommendations of this plan that prohibits multi-family housing or rental properties (see recording for detailed presentation).
