O-380-19 was approved in Appropriations Committee on 11/13/19 (attached). The \$46,000 was appropriated for the "2020 FridayFest Concert Series at Highview Park". D23 gave \$24K, D24 gave \$16K and D13 gave \$6K. \$2K has been spent leaving a balance of \$44,000.

In my opinion, since the ordinance was specific, the funding had to be used for the "2020 FridayFest Concert Series at Highview Park"

I recommend the ordinance be amended to change the wording to "allow" the funding to be used for "FridayFest Concert Series at Highview Park" so the funds can be used for concerts this summer and if any remains to be used the next year OR change the wording to be "2021 FridayFest Concert Series at Highview Park" If it is not amended, I think the \$44K remaining funds need to be returned to the district NDF accounts.

Andrea from Parks has spoken to D23 and they want to keep the funding to use this year. CW Flood and CM Fox, are you willing to use the remaining funds in 2021?

Sonya/LaTonya, do you agree we need an amendment?
