The cost to upgrade the 150W LED Cobra to a 250W LED Cobra will cost \$126.00 for a 5-year lease. Jeffrey Brown stated in his email it would cost \$123.00, but likely he had an old lighting rate sheet.

The 150W cost \$ 10.47
The 250W cost \$12.57
Difference \$2.10 X 60 months = \$126.00
