

Total	=	\$17,840

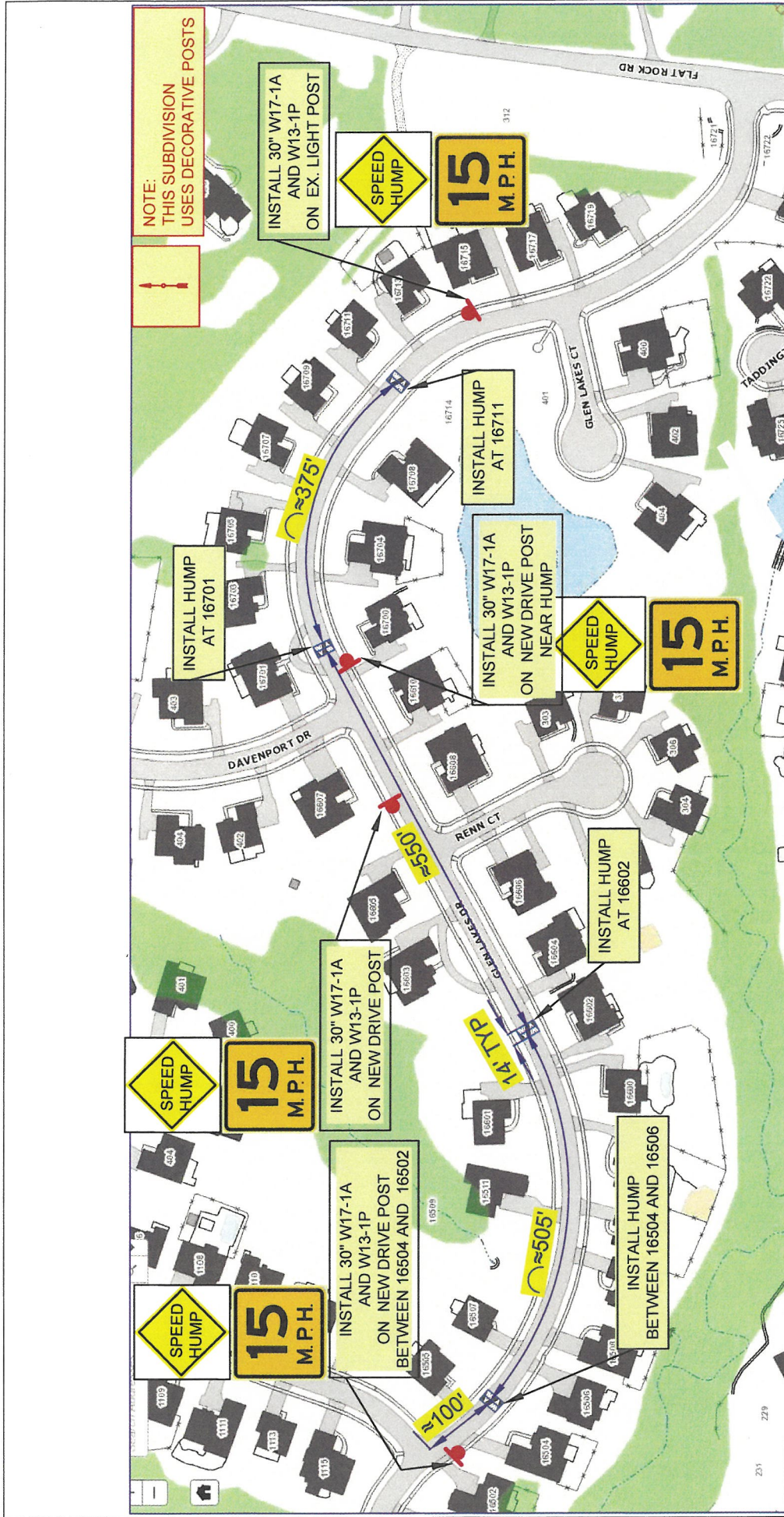

Based on our engineering studies, a total of four (4) speed humps and four (4) speed hump signs have been proposed for Glen Lakes Drive between Malone Place and Glen Lakes Court. The total "not to exceed" cost is **\$17,840**. This statement of cost will be valid for 120 days.

Good afternoon D19 team,

A speed hump investigation was done on Glen Lakes Drive (from Malone Place to Glen Lakes Court). The average daily traffic count was 333 vehicles and the 85th percentile speed was 30.46 mph. Ballot letters were sent to neighbors; a speed waiver was applied since the 85th percentile speed was below the accepted speed (this lowers the allowable percentage of opposition from 30% to 20%). 38 letters were mailed, 5 people (13.2%) responded in support and 3

people (7.9%) responded in opposition. Because the opposition percentage is less than 20%, this project meets neighbor response criteria.

Attached is a statement of cost for Glen Lakes Drive speed humps with layout attached.
