**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (“THE COUNCIL”) AS FOLLOWS:**

**SECTION I:** The sum of \$4,250 is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,500 from District 1; \$500 each from Districts 16 and 20; and \$250 each from Districts 2, 19 and 23; to the Louisville Metro Police Department for costs associated with community outreach and officer support within the Second Division.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval or otherwise becoming law.

Good morning Olivia,

Yes, the 2<sup>nd</sup> Division currently and has been helping many families within our boundaries including seniors for several years while I have been here. My DRO's have roughly 20-30 elderly they visit with each month to check on and make sure they are doing ok. They deliver food boxes with limited staples of food and then some meats. We store some of it here as we keep a deep freezer and most of it is sourced with donated items from Dare to Care. However, many times they need to get other types of food and do so out of pocket.

We also during the holidays of Christmas and Thanksgiving enhance our outreach to additional families providing them with such items as Cornish Hens, Turkeys various drinks and other material items such as blankets or some type of clothing items and we have also given such things as boxes of diapers if needed. Most of these items are not as easily sourced for no cost and officers or advisory members end up paying for things out of their own pocket. We try to keep some things on hand here at the division throughout the month and year but have finally pretty much exhausted our supply of "material items" and need to purchase some new to have in stock at the division so when officers come across a family they need or would like to help, we are able to do so quickly. Most of the families are sourced through patrol officer contact when they come across a person or family while working. They find their living conditions to be below standard or feel a need to help in some way as they are touched by various interactions and just feel a need to help. They then either come to me or contact my DRO's (District Resource Officers) and work to get them something they may need to help. Many times, contacts are through Domestic Violence interaction where a victim needs some quick temporary help as they are transitioning away from their situation. Some examples of items we have given are cans of formula, diapers or fresh set of clothes and stuffed animals and many times paying out of pocket.

Our DRO's work hard to secure as much as they can through donated items or money from various businesses but are not always able to source the exact things we may need for someone. We also have been asked or assisted with small home improvement needs for crime victims such as updated locks, light bulbs, flashlights or replacement of something that has been stolen that we are able to purchase so their life is not as set back. Many times, this type of officer and citizen engagement is simple, but the direct help and kindness of the personal contact goes a long way to making a child or parent better especially when they are a victim of a crime or circumstance, and it provides a positive way to better the police and citizen partnership.
