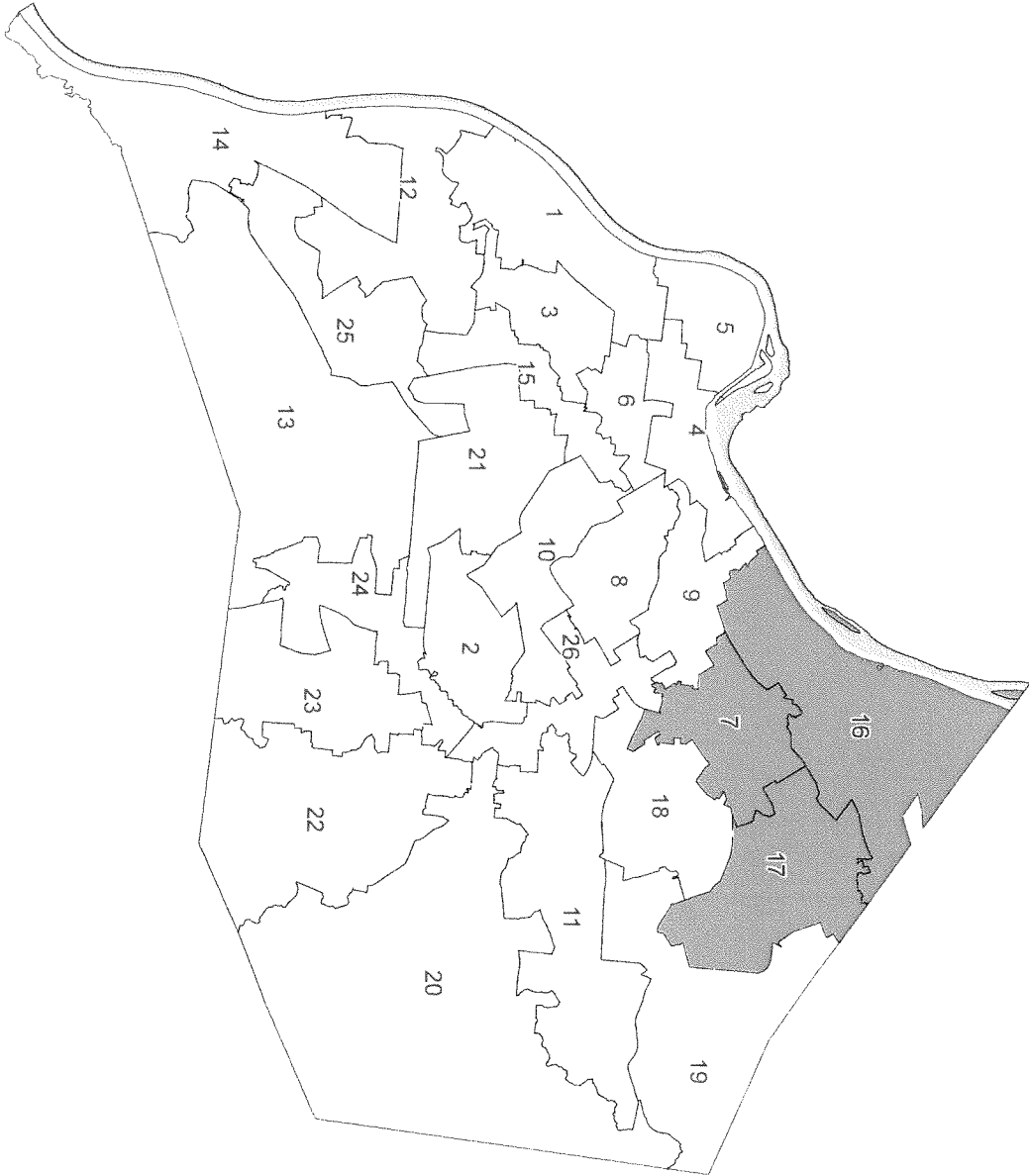
St. Matthews map
