We have to specify exactly where we want the light for LGE, they will not provide us any recommendations, but I'll help with the layout. To start, I will look for existing utility poles in the area since it is a lot cheaper if we do not have to add a pole for the light.

It looks like there is already a streetlight on South Park at the Smith Rd intersection so I left it off the plan for now.

It also looks like there is an existing light at Granger but it must be leased by the property owner so I did include that intersection on the plan.

I've attached a quick plan showing some potential locations that take advantage of existing utility poles. LGE does require a minimum 5-year lease so the appropriation would need to be at least enough for the first 5 years. The cost for the plan I prepared would be \$5,660 for the 5-year lease.




